

Other Business- Old and New

The board expressed concern over the cost of the members event tentatively planned in Herrington this year. It was suggested that we consider scaling back the function. It was pointed out that in the past years it was not an annual event and that we may need to add an additional charge from members to continue this type of event. This event will continue to be discussed in the April meeting.
